## **VII. OLD BUSINESS**

a.Richardson had distributed a written report Tree Removal and Irrigation Projects for review 2018 to all the board members. It was discussed. Lesiak moved to accept the bids #1. Climbing HY Tree Service for removal of trees around the Willow Pond for \$3,392, with goal to complete work prior to full leaf out. #2.Sun & Seed Tree for Poe & 162 entrances tree removal and replacement of \$1,250 with replacement yet to be bid with allowance of \$3,000. Work to be completed by mid April to ensure tree viability. #3. Sun & Seed Tree for Fox Meadow & Fennec Pointe Circle tree removal for \$850 wiht tree replacement budget of \$2,500 to be done by mid April or moved to fall with fall install. #4. Sun & Seed Tree for dead Ash tree removal along # 6 fairway between golf path and Cobblestone / Brownstone backyards – trees are 60 – 70 ft. in height and require bucket equipment for removal. \$3,000 to be done weather / ground permitting for \$3,000. To project figures \$20,000 or under. Lesiak moved to approve. Nolan seconded. Unanimously approved. Project to be discussed later – re-engage irrigations separation project to county for tap at Poe Rd.

Richardson contacted the Property Management Co. for Cobblestone to alert residents of Brownstone whose property back to 6<sup>th</sup> Fairway to NOT DUMP of HOA. Schoen and Richardson will investigate the GFI at RT. 57 main entrance for replacement.

## **VIII. NEW BUSINESS**

a.Dam access was discussed with Jeremy. Klein will discuss a platform access to the dam valve with the club. EAP check was discussed.
